

SUBMISSION GUIDELINES

Artwork to be considered must be original and professionally presented. This is a juried art show. Artists are invited to submit a maximum of one (1) entry (**no exceptions**). The maximum size allowed is 18 inches by 18 inches (18” x 18”) (**no exceptions**). Entries should be ready to hang (3D art is acceptable if it is ready to hang and is compatible with the art display system at the branch). Art must be compatible with the branch’s Walker Art Display System and cannot be hung directly onto the wall. **The library does not provide material such as picture wire to make the art hangable/compatible with the Walker Display System.**

Please Note: Failure to follow submission instructions may lead to disqualification.

Submissions must include the following:

1. The attached Completed Entry Form, to include:
 - Title of the artwork
 - Year created (or approximate)
 - Medium
 - Name of the artist; and
2. The piece of art to be considered for the exhibit; and
3. Signed Exhibitor Waiver Form

EXHIBIT SPACE

All items will be displayed in the Eckstrom-Columbus Library branch, a family venue.

CALL TO ARTISTS

Individuals and non-profit organizations residing in Pima County will have a designated time to submit artwork for consideration by the Art Selection Committee. Flyers/signs will be posted in the libraries and in the community.

ART SELECTION JURY

The Art Selection Jury is generally composed of at least three library representatives.

NOTIFICATION

Following Jury review, the Art Exhibit Coordinator will notify each artist of the Jury’s decision regarding selection of his/her work.

EXHIBITION OF WORK

No price tags may be posted. However, a price list, description of the artwork on display, and biographical and contact information for the artist *may* be left at the Eckstrom-Columbus Information Desk and made available to the public upon request. The library cannot function as an agent for anyone whose works are on display.

INSURANCE

The library does not provide insurance coverage for exhibit items. Exhibitors are responsible for providing coverage for items exhibited at their own risk. No special security is provided for artwork.

INSTALLATION AND DISMANTLING

Artwork will be installed prior to Gallery opening and will be removed after March 25, 2014. All artwork must be picked up no later than March 30, 2015. Questions regarding submissions may be directed to **Mary Givins, Art Coordinator, (520) 594-5285.**
